Notice of Public Hearing to Adopt Rules

A public hearing will be held at the City Hall, 102 Sherman Street, Deadwood, South Dakota, on Wednesday, September 12, 2012, at 9:00 a.m., MDT, to consider the adoption and amendment of proposed rules numbered:

GAMING RULES: 20:18:06:02, 20:18:15:06, 20:18:16:15.18

Proposed Rule Change: ARSD 20:18:06:02, Fee Required with application. The effect of this change is to identify a fee for a gaming property owner license.

The reason for this amendment is to recognize a license fee for gaming property owners, as set forth in SDCL § 42-7B-22.

Proposed Rule Change: ARSD 20:18:15:06, Payment of wagers. The effect of this change would be to allow the option for single-deck blackjack games to be paid at odds of at least six to five.

The reason for this amendment is to recognize a request submitted by the Deadwood Gaming Association on behalf of Cadillac Jack's Gaming Resort in Deadwood.

Proposed New Rule: ARSD 20:18:16:15.18, The play – Fortune Pai Gow poker. The effect of this new rule is to recognize a bonus bet for Pai Gow poker known as Fortune Pai Gow poker and to set forth the rules for the bonus bet.

The reason for this new rule is to recognize a request from ShuffleMaster, Inc., and Cadillac Jack's Gaming Resort.

Persons interested in presenting data, opinions, and arguments for or against the proposed rule changes may do so by appearing in person at the hearing or by sending them to the South Dakota Commission on Gaming, 221 West Capitol Avenue, Suite 101, c/o 1320 East Sioux Avenue, Pierre, South Dakota, 57501-3100. Materials sent by mail must reach the Commission on Gaming by Monday, September 10, 2012, to be considered. However, the Commission requests that all written comments be received by Wednesday, September 5, 2012, to allow for adequate consideration prior to the hearing.

After the hearing, the Commission will consider all written and oral comments it receives on the proposed rule changes. The Commission may modify or amend a proposed rule at that time to include or exclude matters that are described in this notice.

Notice is further given to any individual with disabilities that this hearing is being held in a physically accessible place.
