PIERRE, S.D.—The South Dakota Department of Revenue will offer a pair of popular educational seminars in Winner.

The seminars will be in Winner on March 30 for sales tax and contractors' excise tax training. The sales tax seminar runs from 9 a.m. to 12 noon, and the contractors' excise class seminar takes place from 1 to 4 p.m.
