Introduction

What is a TIF?

<u>Tax Increment Financing</u>, or TIF, is a means of financing public improvements in a defined geographic area, known as a tax increment financing district, or TIF district. In South Dakota, a TIF district can be created by either a municipality or county.

TIF has been authorized in South Dakota since 1978. Over the last 40 years, TIF has become an increasingly popular tool for communities looking to upgrade existing infrastructure or as a means of incentivizing new investments in infrastructure for economic development.

This annual report details project descriptions, valuation information, and timelines for each TIF district.

Section 1: TIF Classification

As of July 1, 2018, South Dakota state law authorizes four classifications for TIF districts: Local, Industrial, Economic Development, and Affordable Housing. TIF district classification is a function of the state-aid to education formula and determines how a given TIF district impacts school funding in South Dakota.

Local

Local classification is the default classification. Unless the TIF district meets the definition of an Industrial, Economic Development, or Affordable Housing TIF district, it is a Local TIF district.

• The projects usually benefit the local government instead of having a regional or statewide benefit.

Example Projects

• Public infrastructure improvements

Impact on State-Aid to Education Formula

- Included in local effort
- The county auditor is required to impose an additional school levy on all real property within any impacted school district to hold the district(s) harmless.

Note: Future annual reports will also provide the increased valuation for each dissolved TIF district as of the date of dissolution. However, this data was not fully compiled as of the date of this report.

Section 1 TIF Classifications (Continued)

Industrial

Industrial classification includes an area where activities are recognized as industrial by zoning authorities. (SDCL 13-13-10.2)

• Including any factory or business whose primary business is the manufacturing or assembly of goods, the processing of raw materials, and the wholesale of products for resale.

Example Projects

- Animal processing plant
- Ethanol plant

Impact on State-Aid to Education Formula

- Not included as local effort in the state aid calculation
- Exempt from imposing an additional school levy on all real property within the district (SDCL 10-12-44(1))

Economic Development

Economic development classification includes any area where there is or will be one or more businesses engaged in any activity defined as commercial or industrial by the governing body that has zoning authority over the land contained within the TIF district. (SDCL 13-13-10.2)

Example Projects

• Public infrastructure improvements for commercial or retail development

Impact on State-Aid to Education Formula

- Not included as local effort in the state aid calculation
- Exempt from imposing an additional school levy on all real property within the district (SDCL 10-12-44(1))

Affordable Housing

Affordable Housing classification includes an area where:

- 1. The original selling price of any house in the district will be at or below the first-time homebuyer purchase price limit being used by the South Dakota Housing Development Authority as of the date the house is sold; OR
- 2. The monthly rental rate of all multifamily housing units in the district will be at or below the calculated rent for the state's eighty percent area median income as of the date the district is created, for a minimum of five years following the date of first occupancy.



Section 2: TIF District Summary

Since TIF was first authorized in 1978, there have been a total of 369 TIF districts created in South Dakota. There are currently 193 active TIF districts.


The chart below shows the number and type of TIF districts created by year since 2011:

The following chart shows how much increment value exists by type of TIF district for the 2020 assessment year (taxes payable in 2021):




Section 3: Dissolved TIFs

A dissolved TIF is defined as a Tax Increment Finance District that has reached the maturity of 20 years since the inception or the approved project has been completed prior to the maturity date.

To complete the end of 2020, a total of 14 Districts were dissolved; Pennington and Davison County dissolved 3, Minnehaha and Brown County dissolved 2, and Brown, Meade, Union and Yankton each dissolved 1.

Since 2015, the number of dissolved TIFs has been between 5-14 districts annually. The rate of annual TIF dissolution is projected to remain the same for the next several years.


Number of Dissolved Districts by Type and Year


