#### eForms Reformed!

Here at the Department of Revenue, we continue to promote convenient and easy ways for the citizens of South Dakota to complete their transactions. With 105 forms available on our online platform, you are now able to submit forms electronically. Electronic submissions can save you time because there is no longer the need to print and turn in a physical copy of the form. We continue to see an increase in popularity of our eForms, with 7,730 forms submitted between October 2019 and May 2020!

Individuals fill out their information and submit the eForm with a click of a button. From here, the eForm is sent on to be processed. After the form is reviewed and signed, the individual will receive an email confirming the eForm has been completed.

# Internet Access Goes Untaxed Beginning July 1, 2020

The Internet Tax Freedom Act of 1998 temporarily stopped states and local governments from imposing new taxes on Internet access and multiple or discriminatory taxes on electronic commerce. The Act had a grandfather clause allowing states that already taxed Internet access to continue enforcing those taxes. South Dakota was included in the grandfather clause.

In 2016, Congress made the Act permanent and only extended the grandfather clause to June 30, 2020.

Starting July 1, 2020, Internet access will no longer be subject to state and municipal sales tax.

### **Municipal Tax Changes**

Beginning July 1, 2020, one South Dakota community will implement a new municipal tax rate. The municipal tax changes taking effect include:

• **Erwin, S.D.,** increasing its 0% general sales and use tax rate to 2%.

South Dakota municipalities are able to implement new tax rates or change existing tax rates on January 1 or July 1 each year.

# Standard License Plate Design Goes Unchanged Till 2023

Governor Noem signed <u>House Bill 1154</u> into law during the 2020 South Dakota Legislative Session, extending the license plate reissue cycle from 5 years to 7 years. As a result, South Dakotans will keep their standard plates until 2023 instead of 2021.

Individuals will receive their new license plates when they renew their vehicle registrations during their renewal month. There is no additional charge to South Dakotans and plates will be provided to them from the state. If you are looking to receive a duplicate plate

because you have damaged your original, the cost will be \$10.

# Keep Your Video Lottery Establishments Clean By Following These Easy Steps



If your video lottery establishments are open, please remember to take the proper steps to protect the health and safety of your employees and customers. Many municipalities have adopted ordinances concerning the coronavirus

(COVID-19) in an effort to mitigate community spread of the virus — you should review any adopted ordinance to determine its application to your establishment.

Be sure to follow guidelines set by the Centers for Disease Control and Prevention (CDC). The CDC recommends that no area has groups of 10 or more people and individuals should be at least 6 feet apart. We all need to do our part to combat the coronavirus and to stop community spread.

Cleaning and disinfecting your facility are also vital in protecting your staff and customers. Be sure to routinely clean frequently touched surfaces with soap and water and/or alcohol-based wipes and sprays. Examples of these areas include tables, doors, countertops, handles, faucets, and toilets.

You should also routinely clean video lottery terminals. Consider putting a wipeable cover on electronics or use alcohol-based wipes and sprays. Be sure to dry the surface thoroughly for best results. Please remind all employees to wash their hands frequently, especially those who are in contact with customers. An employee should wash his or her hands after each transaction.

# South Dakota's Back To Normal Plan

#### **Governor Announces Back to Normal Plan**

COVID-19 has impacted individuals and businesses across the world, reaching pandemic numbers. South Dakota reported their first case on March 10, thus bringing South Dakota into defense mode as many businesses shut down to stop the spread of the disease. On May 1, Governor Noem signed an <u>Executive Order</u>, giving South Dakotans direction as they head back into the workforce and begin transitioning to the "new normal." The Back to Normal plan addresses the following groups:

- 1. Individuals
- 2. Employers
- 3. Retail Businesses
- 4. Public Gatherings
- 5. Schools
- 6. Health Care Provides
- 7. Local Governments

While social distancing is still on the forefront, South Dakotans begin to see light at the end of the tunnel. Online learning and remote work has since increased and the Department of Revenue continues to keep adapting to the changes that we face on a day-today basis.

#### Governor Extends Motor Vehicle Registrations, Renewals, and Titling

Although individuals are able to complete their vehicle registration renewals from one of our DMV Now Kiosks or online, DOR understands that not everyone in the state has access to these resources. In response, Governor Noem announced in her Executive Order that individuals who renew their licenses in March and May have an additional 60 days upon the lift of state restrictions to renew without being charged any penalties or interest. Additionally, any owner of a newly acquired vehicle that has been obtained within the time period covered under the Governor's Executive Order will have 60 days to title and register their vehicle after the emergency order has been lifted.

## The Most Common Contractor's Excise Tax Errors You Need To Know

South Dakota DOR is here to help you better understand what contractor's excise tax is, and the most common errors found in reporting. First, a contractor's excise tax is imposed on the gross receipts of all prime contractors and subcontractors engaged in construction services or realty improvement projects in South Dakota. The gross receipts include the tax collected from the consumer. These gross receipts include the full amount received directly or indirectly in money, credits, property, or liquidated damages for performing construction services or realty improvements in South Dakota.

#### The Most Common Errors Found In Excise Tax Are:

- Not remitting excise tax on owner-furnished materials (OFM). The prime contractor owes excise tax on the value of material furnished by the owner of the construction project, except for qualified utility projects.
- 2. Not reporting excise tax on work performed for local, state, or federal government agencies.
- 3. Excise tax charged on construction services subject to sales tax.
- 4. Not including the excise tax invoiced and collected in reported gross receipts.
- 5. Under-reporting of excise tax due to poor record keeping.

South Dakota DOR employees are available to answer any excise tax questions you may have. They can help with many topics such as; ownerfurnished materials, prime and subcontractors, how to file contractors' excise tax electronically via EPath, and projects for qualifying utilities and governmental agencies, among others.
