

### **Paraplegic**

Defined as an individual with the loss, or loss of use, of both legs.

### **Property**

Defined as the house, garage and the lot upon which it sits, or one acre, whichever is less.

### Eligibility

Individuals applying for either program must own and occupy property that is specifically designed for wheelchair use within the structure.

# Property Tax Exemption for Paraplegic Veterans

The **Exemption** Program requires the paraplegic veteran applicant to own and occupy the property that they are seeking an exemption for. The injury to the applicant does not have to be service-related in order to qualify for the program. There are no income limits for the Exemption Program.

The Exemption Program exempts a veteran's property from all property taxes. Unremarried surviving spouses of veterans are also eligible for the exemption program. Once approved, the exemption remains until the property is transferred or sold.

## How to Apply: For Paraplegic Veteran Exemption

Applications must be submitted to your county director of equalization on or before November 1st. Applications are available in January at the county courthouse or from the Property Tax Division Website at:

## **Property Tax Reduction for Paraplegics**

The **Reduction** Program requires that the paraplegic applicant own AND occupy their property, or be the un-remarried surviving spouse of such paraplegic.

#### **Income Limits**

The Reduction Program is operated using a graduated income scale on income earned in the previous calendar year.

"Income" is your federal adjusted gross income plus any other income (including Social Security payments) The reduction of your taxes is on a graduated scale based on income.

The income limits for the Reduction Program are outlined in the tables **1.1** and **1.2** below:

## How to Apply: For Reduction for Paraplegics

Applications must be submitted annually to your county treasurer on or before April 1st. Applications are available beginning in January at the county courthouse or from the Property Tax Division website at:
