4. Whenever there are less than 3 licenses in any one county, the information is combined into an 'N/A' classification.
5. County and State Totals include 'N/A' amounts.
6. No Contractors Excise taxes are included.
7. Consolidated includes companies that may have locations in more than one county and file one return.
